BUDGET UPDATE: Biosecurity Levy

As reported in the Australian on Monday ("*Container bio levy to speed airport passage*"), the Department of Agriculture and Water Resources (DAWR) looks to be introducing a \$340 million levy on all imported containers - 20' and 40' - from 1 July 2019.

The article suggests that the fee is one of the key recommendations of an independent report chaired by Wendy Craik. The report recommended:

"Funding for the national biosecurity system should be increased by implementing a per container levy on incoming shipping containers of \$10 per twenty-foot equivalent unit and a levy of \$5 on incoming air containers, effective from 1 July 2019".

China - Temporary Restriction of Dangerous Goods (DG) at Qingdao

Please be informed that due to the **Shanghai Cooperation Organization (SCO) Summit, which is scheduled to be held in Qingdao in June 2018**, all import of Dangerous Goods (DG) into Qingdao, Shandong province of China, will therefore be restricted by the Qingdao Maritime Safety Administration (MSA) during the said period, and to entail the following:

- All DG shipments with **ETA from 20 May to 20 June 2018** are prohibited from re-handling, re-stowing or re-shifting at Qingdao port.
- All discharge, loading and in-transit of DG shipments are also suspended from **06 June to 11 June 2018**.

In addition, only DG classified under International Maritime Organization (IMO) Class 8 and 9 (without any other sub-labels) are accepted to in-transit at Qingdao during the period from **06 to 11 June 2018**.

New China Customs Requirement - Tax ID Number

Stockwells wishes to advise clients that as per China Customs' requirement, a Tax ID number for the shipper and consignee must be declared in the manifest for all shipments going to China. Your Tax ID is your ABN.

This mandatory requirement will be applicable for all shipments sailing Australia on/after **1st June 2018**.

Please provide the above information on your shipping instructions. In case of non-compliance with this requirement, Customs fines and other associated costs will be for shippers' account.
